# **From Mæxico to Mexico Sweepstakes**

Official Rules

9. maj 2021

## Eligibility

The Mæxico "From Mæxico to Mexico" (the "Sweepstakes") is open only to legal residents of Denmark who are at least eighteen (18) years old at the time of entry. The Sweepstakes is subject to all local and national laws and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Receiving an entry is contingent upon fulfilling all requirements set forth herein.

## Timing

The Sweepstakes begins on May 24<sup>th</sup>, 2021 at 09.00 and ends at 09.00 on Juli 15<sup>th</sup>, 2021 (the "Sweepstakes Period"). The Sweepstakes consists of a single drawing. The drawing will be conducted among all eligible entries in accordance with the Random Drawing Schedule below.

## How to enter drawings

In order to enter the Sweepstakes

During the Sweepstakes Period, participants need to share their experience at Mæxico Vesterbrogade 'Vesterbrogade 58, 1620 Copenhagen C'. The experience needs to be shared on one of the following platforms: LinkedIn, Facebook or Instagram.

The experience needs to include a picture of the physical location or food served from Mæxico Vesterbro, tagged with the location 'Mæxico Vesterbro'

To submit an entry to the Sweepstakes, a link will be available via the website [maexico.com](http://maexico.com). Participants need to fill out the entry form with a screenshot of the shared experience on social media, First and Last Name, phone number, and email address. You must correctly answer the questions on the form in order to be eligible for the drawing.

LIMIT: one (1) entry per person regardless of method of entry. DRAWINGS Administrator will conduct one (1) random drawing to determine one (1) winner per Entry Period from among all eligible entries received on or about the Drawing Dates set forth below. Entries generated by any means inconsistent with the terms of these Official Rules or which, as determined by

Administrator or their staff (the “Sweepstakes Entities”) in their discretion, contravene the spirit of the entry process described herein, will be void and ineligible for the random drawing. Odds of winning a prize for an individual Entry Period depend upon the number of eligible entries received during that specific Monthly Entry Period.

### **Prize**

A trip for two persons to Mexico at the maximum value of DKK 15.000,00 including VAT. The Prize will ultimately be delivered to the Winner in the form of a gift certificate to a travel agency, determined by Administrator or their staff (the “Sweepstakes Entities”). Prize cannot be substituted, assigned, or transferred. Winner may make no substitution or transfer of prize and prize is not exchangeable for cash. The Winners shall bear all risk of loss or damage to their prize after it has been delivered. Mæxico will not replace prize that is lost, stolen, or misdirected. The prize will be awarded “as is” without warranty of any kind, either expressed or implied, including but not limited to, the implied warranties of merchantability and fitness for a particular purpose. Mæxico reserves the right to substitute a prize with one of comparable use should the advertised prize become unavailable for any reason. By accepting a prize, Winners acknowledge compliance with these Official Rules. Please allow up to 52 weeks for delivery of prize.

### **Winner Notification**

Administrator will notify the selected winners within approximately five (5) days after the applicable Drawing Date by email only. If the potential winner does not respond to the email within three (3) business days of the email message, the prize is forfeited, and an alternate winner will be chosen provided there are a sufficient number of qualified entrants. Upon forfeiture, no compensation will be given. The potential winner may be required to complete, sign and return an “Affidavit of Eligibility and Release” including, where legally permissible, a Publicity Release, within seven (7) days of date receipt of the Release document.
